

## **ADDENDUM TO MEMORANDUM OF UNDERSTANDING**

This Addendum to the *Memorandum of Understanding dated 31.07.2017* entered into between CHUBU University, Japan and Anna University, Chennai, India on this the 07<sup>th</sup> day of September 2022.

Whereas, an earlier Memorandum of Understanding (MoU) dated 31.07.2017 was drawn up and agreed upon to establish the cooperation between the **Anna University** located at Chennai 600 025, Tamil Nadu, INDIA and the **International Digital Earth Applied Science Research Center, Chubu University** (hereinafter referred to as IDEAS) located at 1200, Matsumoto-cho, Kasugai-shi, Aichi, Japan.

Whereas, the aforesaid Memorandum of Understanding had expired on 31.07.2020 and the parties had continued their working relationship to further the objectives of the said earlier of Memorandum of Understanding on the terms and conditions enlisted thereunder.

Whereas, the parties intend to continue their collaboration in terms of the earlier Memorandum of Understanding dated 31.07.2017 and are thus executing the instant *Addendum to the Memorandum of Understanding dated 31.07.2017* to record the same in writing.

### **NOW THIS ADDENDUM TO THE MEMORANDUM OF UNDERSTANDING DATED 31.07.2017 WITNESSETH AS FOLLOWS:**

1. The Agreement between the Parties shall be effective from the date of signing of this instrument up to a period of three years and may be renewed by mutual consent.

2. All clauses of the earlier Memorandum of Understanding dated 30.07.2017 save for [Article III (1)] between the parties shall remain unchanged and shall be read as part and parcel of the instant Addendum.

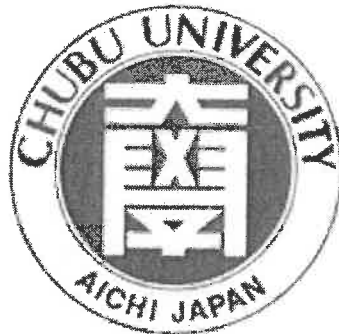

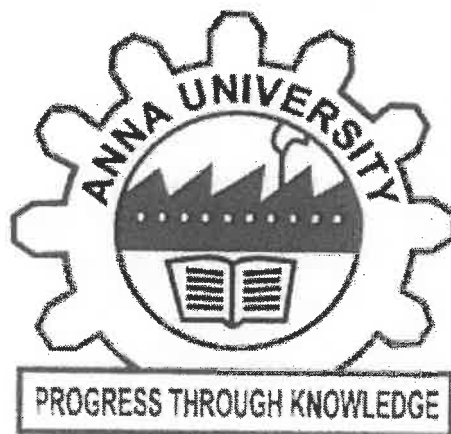

## MEMORANDUM OF UNDERSTANDING

Between  
Anna University, Chennai, INDIA  
and  
Chubu University, JAPAN

This Memorandum of Understanding (MoU) is drawn up and agreed upon to establish the cooperation between the Anna University located at Chennai 600 025, Tamil Nadu, INDIA and the International Digital Earth Applied Science Research Center, Chubu University (hereinafter referred to as **IDEAS**) located at 1200, Matsumoto-cho, Kasugai-shi, Aichi, Japan.

Anna University was established on 4th September 1978 as a unitary type of University. It offers higher education in Engineering, Technology and allied Sciences relevant to the current and projected needs of the society. Besides promoting research and disseminating knowledge gained there from, it fosters cooperation between the academic and industrial communities. The University was formed by bringing together and integrating two well-known technical institutions in the city of Chennai (Madras) namely College of Engineering, Guindy (CEG) (1794), Madras Institute of Technology, Chromepet (MIT) (1949) and three Technological Departments namely University of Madras, Alagappa College of Technology (ACT) (1944) and School of Architecture & Planning (SAP) (1957). From December 2001, the University has become a large, highly renowned University with affiliating status.

Chubu University is located in Kasugai, Aichi, Japan. It was founded in 1938 by Kohei Miura, originally a professor at Nagoya Institute of Technology. Masters courses were added in 1971, and Doctoral courses in 1973. The school has courses in many disciplines in both Humanities and Sciences. With the addition of the new College of Contemporary Education, Chubu University has become a comprehensive university encompassing 7 colleges and 30 departments in the arts and sciences. Initially this was established as a pre-eminent technical university for the Chubu region.

## ARTICLE I. PURPOSE

The purpose of this MoU is to enable cooperation between Institute of Remote Sensing (IRS), Anna University and International Digital Earth Applied Science Research Center (IDEAS) and deepen the longstanding friendly relations between the two institutions and mutually promote academic, scientific and cultural exchange activities.

## ARTICLE II. SCOPE

The activities under the scope of this MoU are:

1. Exchange of faculty, researcher and students;
2. Development and promotion of cooperative research program and activities;
3. Development of cooperative education and training programs including offering credit, short-term and long-term workshops, seminars, courses and offering degrees.
4. Exchange of information and documents which are of mutual interest; and
5. Arranging meetings, lectures, club activities, and other events of mutual concern.

## ARTICLE III. DURATION, TERMINATION, AND AMENDMENT

1. This MoU will be effective from the date of signing by both parties up to a period of three (3) years, and may be renewed by mutual consent.
2. Either party may terminate this MoU by giving six (6) months advance notice in writing to the other party.
3. The provisions of this MoU may be amended at any time with the mutual consent of the Parties in writing.
4. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination, and expiration unless otherwise agreed upon between the parties.

## ARTICLE IV. SPECIAL PROVISIONS

1. Each party will consult with and take approval of the other party to use the latter's name, the names of the latter's officials/faculty members, and the logo for the activities under this MoU, and dissemination of results, on a case-by-case basis.
2. Modalities of each type of collaboration, associated activities and financial aspects shall be mutually agreed upon on a case-by-case basis in separate Memorandum of Agreements (MoA).
3. The two parties will consult with each other and attempt to resolve disputes or misunderstandings that arise in the administration of this MoU or any subsequent associated agreement informally.


